

Voting Report, Q1 2022

EOS at Federated Hermes

Over the last quarter we made voting recommendations at 252 meetings (2,571 resolutions). At 124 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at seven meetings and abstaining at three meetings. We supported management on all resolutions at the remaining 118 meetings.

Global

We made voting recommendations at 252 meetings (2,571 resolutions) over the last quarter.



- Total meetings in favour 46.8%
- Meetings against (or against AND abstain) 49.2%
- Meetings abstained 1.2%
- Meetings with management by exception 2.8%

Australia and New Zealand

We made voting recommendations at **four** meetings (**15** resolutions) over the last quarter.



- Total meetings in favour 50%
- Meetings against (or against AND abstain) 50%

Developed Asia

We made voting recommendations at 63 meetings (521 resolutions) over the last quarter.



- Total meetings in favour 60.3%
- Meetings against (or against AND abstain) 39.7%

Emerging and Frontier Markets

We made voting recommendations at **65**meetings (**408** resolutions) over the last quarter.



- Total meetings in favour 53.8%
- Meetings against (or against AND abstain) 44.6%
- Meetings abstained 1.5%

Europe

We made voting recommendations at **35**meetings (**667**resolutions) over the last quarter.



- Total meetings in favour 22.9%
- Meetings against (or against AND abstain) 68.6%
- Meetings abstained 5.7%
- Meetings with management by exception 2.9%

North America

We made voting recommendations at **42**meetings (**384**resolutions) over the last quarter.



- Total meetings in favour 23.8%
- Meetings against (or against AND abstain) 69.0%
- Meetings with management by exception 7.1%

United Kingdom

We made voting recommendations at **43** meetings (**576** resolutions) over the last quarter.



- Total meetings in favour 58.1%
- Meetings against (or against AND abstain) 34.9%
- Meetings with management by exception 7.0%



We recommended voting against or abstaining on **five** resolutions over the last quarter.




Developed Asia

We recommended voting against or abstaining on 7.7 resolutions over the last quarter.




Emerging and Frontier Markets

We recommended voting against or abstaining on $10\,0$ resolutions over the last quarter.




Europe
